

1. Issue a temporary immediate stay of the June 5, 2018 primary election for Ventura County Sheriff pursuant to Cal. R. Ct. 8.112(c)(1) pending the ruling on this petition;
2. Issue a writ of supersedeas staying the June 5, 2018 primary election for Ventura County Sheriff pending a ruling on Petitioner's appeal;
and
3. Award Petitioner such other and further relief as the Court deems just and proper.


